Lowland canals threatened with closure

KEEP Canals Alive!, a group of 11 voluntary organisations, has sent an open letter to the chief executives and council leaders of the local authorities through which the Lowland canals run, asking for their support in persuading the Board of Scottish Canals to meet its statutory obligations.

The group is asking that Scottish Canals realign its priorities to ensure that the canals do not return to the dreadful state that they were in before the Millennium. Pictures of Ratho and Glasgow taken less than 10 years after the Forth & Clyde was originally closed in the 1960s, vividly illustrate how canals can deteriorate once large boats stop moving along them

The seven local authorities played a pivotal part in the work to re-open the canals after years of dereliction. Of the £79 million raised on the initial Millennium Link project, £7.2 million was contributed directly from council funds. Each council has seen the benefit from the canal restoration, both social and economic. The councils will be the first to feel the effects of degeneration but without the ability to do anything directly to stop the decline.

The Millennium Link was a successful cooperation between Central and Local Government, aided significantly by the voluntary sector whose contribution was valued at £2.4 million. Much of that was through the provision of large passenger boats, mainly operated by charities, which take almost 30,000 people on day trips each year. Private companies have produced a fleet of 19 hire boats that enabled 494 family holidays to be taken cruising through central Scotland last year, with an estimated spend of £250,000 by holidaymakers.

Many of the organisations involved with *Keep Canals Alive!* came into being before the Lowland canals were reopened, taking part in early canal clean-ups, and vigorous campaigning for the complete restoration of the canals.

Ronnie Rusack , well-known canal enthusiast and campaigner and chairman of the Lowland Canal Voluntary Group, says: "After 47 years of campaigning for the Lowland canals I'm not prepared to allow them to deteriorate any further and slip back to becoming remainder waterways.

"The Scottish Lowland Canals are not only part of our heritage but play a vital role in tourism, health and the well-being of the Scottish people and have something for everyone as proved by their usage. I am delighted to have received expressions of support from councillors of all shades of opinion in three areas already."

The local authorities are: East Dunbartonshire Council, Edinburgh City Council, Falkirk Council, Glasgow City Council, North Lanarkshire Council, West Dunbartonshire Council, and West Lothian Council.

Keep Canals Alive! comprises of eleven voluntary organisations who have joined forces to campaign against and prevent the dereliction of the Lowland canals. These include Bridge 19–40 Canal Society; Capercaille Cruisers; Edinburgh Canal Society; Forth & Clyde Canal Society; Forth Yacht Clubs Association; Linlithgow Union Canal Society; Lowland Canals Association; Lowland Canals Volunteer Group; Re-Union Canal Boats; RYA Scotland and Seagull Trust Cruises.

Society Boat Gathering

A mass Society Annual Boat Gathering (well, there were <u>two</u> boats in attendance) was held at Flecknoe and Braunston over the early May bank holiday weekend. The crews consisted of our Chairman and Secretary, Alan and Angela Rose, on their boat 'Liberty' and former Chairman and Treasurer, Paul and Gill Herbert, on 'The Evelyn Broadbent'.

Alan and Angela had been working on their ex-working boat 'Purton' at its mooring at Ventnor Marina near Calcutt Locks on the Grand Union

Canal where 'The Evelyn Broadbent' is also moored.

Saturday morning, after shopping at Napton Village, Gill and I got our boat ready to cruise (our first cruise of 2018) whilst Alan and Angie drove over to Holt Farm at the top of Napton Locks to bring down their second boat, 'Liberty, on which they were going to spend the weekend - both boats to meet up at the usual Gathering location at the Flecknoe Farm moorings on the Napton-Braunston Five Mile Pound.

The weather over the whole weekend was simply glorious - very

warm/hot and sunny. The canal was incredibly busy and we felt this was due to people wishing to get out on the water after such a long and wet winter. During the afternoon/early evening the Flecknoe moorings quickly filled up, almost nose to tail (OK then – I should have said bow to stern). We have never seen so many boats moored there.

It had been the intention to have a BBQ on Saturday evening but it was pretty warm so we decided to put that in abeyance. Sunday dawned – another lovely warm day and that evening we did manage the BBQ – and very nice too. We chatted with the couple on the boat moored ahead of us who were about to move onto their boat as liveaboards.

We gave them (hopefully helpful) advice about conditions they might face, particularly during the winter months. We also got into conversation with the owner of another boat on the moorings who was taking it to Crick to sell. It was obviously a reluctant decision by him and his wife so we suggested it might be better to change down to a smaller boat. They seemed happier with that alternative. To cap off that evening we witnessed the ghostly sight of a large barn owl skimming over the canal past our moorings – a beautiful image.

> On the Monday morning we cast off and drifted down to moor in Braunston. With so many boats around we were a little concerned about finding space to moor but we must have timed it right and both managed to get in. Off we then walked to Midland Chandlers to purchase some bits and pieces for our boats before reversing to the twin bridges at Braunston Turn, winding and heading back to Ventnor Marina and the Napton Engine Arm respectively. Later that evening Alan and Angela drove back to Ventnor Marina and 'Purton'.

The next morning Alan and Angela continued working on 'Purton', getting it ready for its next cruise whilst Gill and I packed up 'The Evelyn Broadbent' ready for our drive home. Before leaving we made a special 'presentation' to Alan of a pencil (see photo) – he had lost his only one on board!

Looking back, it was a really enjoyable weekend and it was a shame that other Society boat owners were unable to share in our experience.

BM pulls plug on 2019 London Boat Show

BRITISH Marine, which organises and owns the London Boat Show, has announced that the 2019 Show, due to run at ExCeL London from January 9-13, 2019, will not take place.

This decision was made after independent research by exhibition experts, Zing Insights, showed there was insufficient support from a large proportion of the marine industry to the show with its current format, duration and location.

"The decision to put the London Boat Show on hold is naturally very disappointing for the British marine industry," said David Pougher, president of British Marine, "but British Marine and its Board of Directors has a responsibility to its members and we cannot commit to running a show which is clearly forecasted in its current format to be commercially unviable and will not meet customer satisfaction levels."

Personal interviews with over 67% of exhibitors have revealed that whilst a number of marine companies supported the change to a fiveday show, a large number of key exhibitors were not prepared to commit to next year's show at ExCeL. Visitor research also showed that consumer satisfaction of the 2018 Show was below acceptable industry standards.

Zing's research findings were endorsed by British Marine's exhibition sales staff who, despite intensive sales efforts, reported that an insufficient number of signed contracts of commitment to the 2019 Show had been returned.

Sales activity and support for the London Boat Show is in contrast with British Marine's TheYachtMarket.com Southampton Boat Show, which attracts close to 500 exhibitors and more than 106,000 visitors. The 2018 event, running over 10 days from September 14-23, is significantly ahead in terms of ticket sales and exhibitor sign ups compared to this time last year.

British Marine says making the decision to put the London Boat Show on hold now for 2019 enables the organisation to look at alternative options.

The minutes of the 49th Annual General Meeting held on 7 July 2016 had been provided to all members. On being put to the vote, the minutes were accepted by the members present.

There were no matters arising.

4. Chairman's Report

The Chairman provided his report prior to the meeting in the society Newsletter. Alan also provided a brief synopsis of his report to the meeting. He noted that the member's photographic evening was well supported. It was also notable that some new visitors to the society attended some of the talks held during the year.

The Chairman welcomed suggestions for potential ideas for future talks.

He also wished to mention again his condolences for the passing of Laurie.

He thanked the committee members for their efforts and Peter Oates for all his work in producing the newsletter. He also expressed his thanks for the wider membership and their attendance throughout the year.

5. Secretary's Report

The Secretary's report had been published prior to the meeting in the Newsletter. Angela thanked the committee for their efforts. She reported that there had been an average of 25 persons at the previous year's meetings.

The society had continued to advertise in the local media and all new attendees had been followed up to encourage further involvement. Some general discussion of attendance followed.

Angela noted the value to the society of the raffle.

6. Treasurer and Membership Secretary's Report

The Treasure's report and accounts for the previous year were presented prior to the meeting, which had been audited and signed off. Aelred provided a verbal summary of his report:

Subscriptions were down slightly but overall the accounts show a small surplus. Other items were explained including:

Hall hire; Daystar production; Book sales; Jubilee boat trip; Membership; and Raffle income.

Aelred concluded that there was no requirement to raise subscriptions at present, although the hall rental may be expected to increase in the future.

It was noted that the Jubilee trip had been a great success and widely enjoyed.

Acceptance of the accounts was proposed by Terry Phippard and seconded by Brenda Pomeroy.

7. Future of the Society

The note in the Newsletter was read to the meeting by the Chairman, as an introduction to this agenda item. Discussion of the topic followed with strong feelings expressed both in support of the society and the problems of continuing.

Eric Lewis advocated option 5 (The closure of the society after a period of time). He considered the society was fading away, but did not want it to just fizzle out. He doubted that other members would be prepared to take on the commitee positions.

Tony Fry explained why the Salisbury Canal Society had moved to a less formal status, which had been due the IWA requirements for certain financial accounts and arrangements. Eric also provided additional detail on this point. The society did have similar problems with falling attendance.

Eric expressed the opinion that only those members who were prepared to contribute in some way should vote to continue the society.

Brian Evans wished to continue the society. He identified that Peter Oates's contribution to the Newsletter was critical in this regard. He thought that Peter had enjoyed the recent increased involvement in news material with regard the anniversary material and thought Peter would be prepared to continue so long as he was provided with material. Brian and Annegret explained the effort that had gone into the society and the difficulties of continuing. It was suggested that the appointment of a publicity officer could assist the committee. Brian favours continuing with the Status Quo so long as the society is financially viable.

Aelred questioned if the social aspect of the meeting was sufficient justification for the continuation of the meeting schedule.

Gordon suggested moving to a six monthly society meetings, with renewal decided each year, in February.

Brenda Pomeroy expressed the opinion that the society can't keep going if members are not willing to stand and contribute.

Terry Phippard agreed with Eric's opinion, to continue the society for at least one more year.

Brian still advocates the social aspect of the society. Additionally it is now the only society of this standing in the area.

Brian continued saying that campaigning is less active now, but the need for campaigning is still there. Eric agreed with this point. Alan identified that active campaigning was still taking place by him and other members, albeit not as part of the society.

Environment Agency calls for action on water efficiency

RIVERS and wildlife could be left without sufficient water unless action is taken to reduce water use and wastage, according to an Environment Agency report published today.

The first major report on water resources in England states that climate change and demand from a growing population are the biggest pressures on the availability of water. Without action to increase supply, reduce demand and cut down on wastage, many areas in England could see significant supply deficits by 2050 – particularly in the south east.

The State of the Environment: Water Resources report highlights unsustainable levels of water abstraction, leakage from water companies – currently estimated at 3 billion litres per day – and demand from industry and the public as three of the issues to tackle in order to protect the water environment.

EA chairman Emma Howard Boyd said: "We need to change our attitudes to water use. It is the most fundamental thing needed to ensure a healthy environment but we are taking too much of it and have to work together to manage this precious resource.

"Industry must innovate and change behaviours in order to reduce demand and cut down on wastage – and we all have a duty to use water more wisely at home.

"With demand on the rise, water companies must invest more in infrastructure to address leakage instead of relying on abstraction and the natural environment to make up this shortfall."

The report shows that current levels of water abstraction are unsustainable in more than a quarter of groundwaters and one fifth of rivers, leading to reduced flows which could damage local ecology and

Annual General Meeting 2018

In accordance with the Constitution, notice is hereby formally given of the Southampton Canal Society's Annual General Meeting on the 5th July 2018 at Chilworth Parish Hall, Chilworth Road, Chilworth, Southampton at 7.45pm.

Please note that the papers associated with the AGM (Agenda, Minutes of last year's AGM, Officers' reports and the Society's accounts) are published on pages 5 to 9 of this Newsletter. Previously, unsustainable abstraction has prevented up to 15% of rivers meeting good ecological status – including globally important chalk streams. Summer river flows and groundwater levels may decrease further in the future.

Last year the government announced a plan for abstraction reform which will review existing licences and introduce more controls to protect water resources. The Environment Agency has started work in four priority catchments to test out new licensing approaches to help meet local demand.

Of the water taken from freshwater sources over half (55%) is abstracted by water companies for public water supply and more than a third (36%) is used for electricity supply and other industries. The Environment Agency has urged water companies to pursue ambitious water resource management plans and called on industry to play its part to find ways to use water more efficiently.

The government's 25 year environment plan sets out an ambition to reduce individual water use – on average 140 litres per person each day – by working with industry to set a personal consumption target. The Environment Agency will work with the government to set this target and cost-effective measures to meet it.

The Environment Agency plays a key role in protecting water for people's lives and livelihoods – by responding to pollution incidents, prosecuting offenders, regulating abstraction and improving water quality along rivers and beaches.
